Report

By Gazettal Notice dated 8th September 2000, the Order detailing the newly created Wards within the District and the number of Councillors to be elected to represent those Wards at the 6th December 2000 elections, was published.

As the Act specifies that the agreement and appointment of the Electoral Commissioner must be formalised within a timeframe not less than 80 days prior to the elections, it is necessary for Council to reaffirm its previous decisions relating to the appointment of the Commissioner to conduct the elections, as well as have the election conducted as postal elections.

As this timeframe expires on the 17th September 2000, it is not possible for this issue to be determined at the next Ordinary Council Meeting to be held on the 19th September 2000.



By letter dated and received by Council on the 8th September 2000, the Electoral Commissioner agreed to be responsible for the conduct of these elections specifically.
