As the Council of the City of Cockburn only has one employee (its Chief Executive Officer), I therefore make the assumption that the consideration of the staff matters at this Special Meeting can only be about the CEO, Mr Stephen Cain. As such I have the following questions.:

- Q1. If, as reported in the media, Mr Cain's assertion that there has been bullying of him and others is upheld, what actions will the Council take to prevent this reoccurring?
- A1. Mayor Howlett advised that an initial response to the issue raised is the subject of a Confidential Report to be considered by Council tonight.
- Q2. How much has it cost the City's ratepayers for the investigations and associated legal fees into the bullying and misconduct allegations?
- A2. Mayor Howlett advised these costs are not known at this stage.
- Q3. Under the Strategic Plan and Policy Implications, Agenda Item 10.1 refers to 'governance delivered through transparent and robust processes'. As all of these matters have been dealt with behind closed doors and remain undisclosed, what advice will the Council provide to the community of the outcomes of the bullying and misconduct matters, so that it has transparency as to what has occurred?
- A3. Mayor Howlett advised that any disclosure of Council decisions will need to be agreed by Council resolution.
